#### 31 March 2024 LGPS Year-End

Please allocate resources to ensure that by 30 April your end of year return can be emailed to Stephen It is very important that you supply us with accurate membership and pay details for your employees, as in the CARE scheme every year stands alone rather than being based on one final pay figure. An inaccurate pay for one year will be revalued every year by the Consumer Prices Index until the benefits are taken, meaning that, if your employee's benefits are not correct, we will have to untangle the error, perhaps after many years of revaluation.
