FREQUENTLY ASKED QUESTIONS

CAN I VIEW MY PENSION ONLINE?

Yes, you can view your pension by logging in to the member portal.

CAN I OPT OUT OF THE LGPS?

Yes, you will need to complete an [Opt Out Form](#) and send this to your employer/payroll so they can stop your pension deductions.

CAN I REDUCE HOW MUCH I AM PAYING IN?

If you are thinking of opting out, you might want to first consider moving to our 50/50 section of the scheme where you are able to pay half your normal contributions in return for half your normal pension build up.

CAN I MAKE EXTRA CONTRIBUTIONS TO INCREASE MY BENEFITS?

You can increase your benefits by paying additional contributions, known as Additional Pension Contributions (APCs) to buy extra LGPS pension, or by making payments to the Scheme's Additional Voluntary Contributions (AVC) arrangement.

AT WHAT AGE CAN I ACCESS MY PENSION BENEFITS?

You can start taking your pension from age 55 (57 from 06 April 2028), please note taking your pension earlier than your normal pension age may result in early payment reductions being applied.



DEATH GRANT NOMINEES

In the unfortunate event of your death, a death grant of 3 times your assumed pensionable pay is paid out to your chosen nominees.

You can nominate any individual and/or organisations, if you are splitting your nominations ensure the percentage share totals 100%.
