Outsourcing of Contracts and Academy Conversions

We can only begin the process of transferring members between employers once we receive a formal request from the outsourcing or letting employer, or from the school converting to academy status. Under the LGPS Regulations, it is the statutory responsibility of the outsourcing or letting employer (or the school) to notify us of such changes.

If this request is not made before the employees transfer, their LGPS membership may be incorrectly linked to the wrong employer. This can lead to difficulties in collecting contributions, processing retirements, or handling death in service cases.
