Please can all employers ensure they are continuing to send leavers forms in for members who are retiring and taking their pension so we can avoid delays in making payments.

For backdated pay for leavers please can employers not submit these via i-Connect as this will create additional records. If there is any backdated pay, please can this be forwarded in the form of either a leaver form or a spreadsheet if there is a large batch.

#### **2025 LGPS Annual Benefit Statements**

If there are any discrepancies with pay, members should contact you as the employer in the first instance, details such as address changes can now be updated by the member on the member portal.
